## Mr Arnaud de David-Beauregard takes over as the new CLEPA President

At its General assembly in Madrid CLEPA appointed Mr Arnaud de DAVID-BEAUREGARD, Vice-President, Operating Officer of FIEV, as the new CLEPA President starting functions on 1 January 2014.

the Executive Committee of Faurecia, he became Executive Vice-President, Group Development, from 2000 until 2010. He is holding the position of Vice-President, Operating officer of FIEV (French automotive component industries association) since May 2010 and has been a member of the Steering Committee of CLEPA since December 2012.

In spite of the crisis the automotive supply industry remains one of Europe's largest employer and leader in innovation. The automotive suppliers collectively employ five million people in Europe making it a major creator of wealth.

I am confident that with his background in automotive operations and national associations, Arnaud will further build on the solid track record of Mr Peter Tyroller, Member of the Board Management of Robert Bosch, who was at the helm of the European Association of Automotive Suppliers for four years", said Jean Marc Gales, CLEPA CEO.
